# ALL ON THE WALL CALL FOR ENTRIES

Have you ever wanted to see your art on the walls of Montpelier Arts Center? In the antithesis of a curated exhibition, local artists are invited to submit artwork to be included in our 2025 community showcase, All on the Wall, in the Library Gallery.

## ELIGIBILITY

Open to Prince George's County artists ages 18+. Artwork cannot have been previously exhibited at the Arts Center.

## REQUIREMENTS

- Each artist may submit one (1) original piece of artwork, created by the artist.
- Artists may submit drawing, painting, photography, collage, printmaking, mixed media, digital based imagery, and wall-mounted sculpture.
- Artwork must not exceed 24 inches in any direction.
- Work must be prepared to hang on the wall and must weigh less than 30 lbs., including frame.
- Work using materials that are hazardous to the health and safety of the public will be disqualified.

## ARTWORK DROP-OFF

Artwork will be accepted at Montpelier Arts Center **March 4 & 5, 2025**, 10 am–8 pm until the walls are filled. The Drop-Off/Pick-Up Release Form must be completed and signed. Artists are solely responsible for transporting work to and from the Arts Center.

## ARTWORK PICK-UP

Any artwork not sold must be retrieved from Montpelier Arts Center **March 30–April 6, 2025**. Work not picked up within 30 days of the pick-up window may be discarded at the discretion of staff.

## SALES + INSURANCE

It is recommended, but not mandatory, that artists price their artwork for sale. The Maryland-National Capital Park and Planning Commission (M-NCPPC) will retain 25% commission on all artwork sold during or as a result of the exhibition. The M-NCPPC will insure all consigned artwork in the custody of Montpelier Arts Center from official drop-off dates to pick-up dates only. The Arts Center will not be responsible for any loss or damage of any artwork outside of official delivery and pick-up dates. Submission of artwork to the All on the Wall exhibition indicates agreement with the stated conditions.

<b>Artwork Pick-up:</b>	March 30–April 6, 2025 (Sat.–Sun. 10 am–5 pm; Mon.–Thurs. 9 am–8 pm; Fri. 9 am–6 pm)
