REMINDERS

Performance Reservations:

Remember to register early for the performances you like! Performance reservations will remain available on a "first come, first served" basis, with limited spaces available for each activity/performance. Each performance will include cost per ticket, a unique ParksDIRECT activity code, date, time, and registration period. Once you have selected the performance(s) you would like to attend you can purchase it online with a ParksDIRECT activity code at www.pgparksdirect.com, in person at any community center, or with the Special Programs Division office.

<u>Please note:</u> **ALL TICKET SALES ARE FINAL**. Ticket fees are due at the time of the reservation and are non-refundable after the deadline.

Eligibility Criteria:

As a Performing Arts Club member, you (1) must be able to remain in a large group with a 1:6 staff-to-participant ratio, (2) pay attention to the performance, (3) stay seated and quiet during performances, and (4) handle personal needs with minimum assistance.

Safety:

To ensure your safety, we ask that you carry a personal identification card, such as an MVA ID card, with you on all activities.

Meet up:

Unless stated otherwise, PAC will meet at 6611 Kenilworth Avenue, Riverdale, MD, at the parking lot on the left side of the entrance by the designated meeting time. Please be on time because staff can only provide a 15-minute grace period for latecomers.

Pickup:

Please be sure your ride is on time. Due to traffic or other unforeseen issues, the group may arrive slightly later or earlier than stated in the newsletter. Unless otherwise communicated, please adhere to the pickup time stated in the newsletter.

A late pickup fee of \$10 will be assessed for every 15-minute increment of late arrival. This includes public transportation such as Metro Access and ride services such as taxis, Uber, and Lyft. Continued late pickup could result in the cancellation of your club membership.

Attire:

Dress to impress! Unless otherwise stated, please do not wear jeans, sweatpants, sweatshirts, tennis shoes, etc. to the performances. Business casual attire is good.

Refreshments:

Most venues offer refreshments ranging in price from \$2.00 to \$10.00. If you would like to purchase a snack (candy, chips) and/or drink, it is recommended that you bring at least \$10.00 for each performance.
